The MSCI World is published by the US financial services provider MSCI and is regarded as one of the most important share indices worldwide.

The “Euro Stoxx 50” is a share index made up of 50 large, listed companies in the eurozone. It is regarded as one of the leading stock market barometers in Europe. The Euro Stoxx 50 is to be distinguished from the STOXX Europe 50, which also includes European companies outside the eurozone.

The “S&P500” (Standard & Poor’s 500) is a share index comprising the shares of 500 of the largest listed US companies. The S&P 500 is weighted according to market capitalisation and is one of the most widely followed share indices in the world.

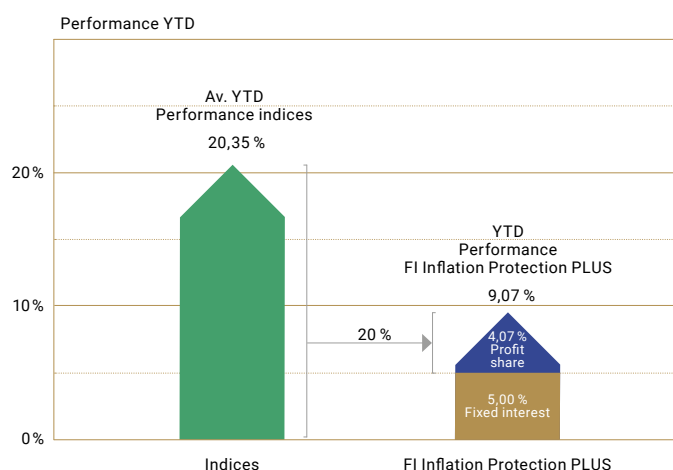
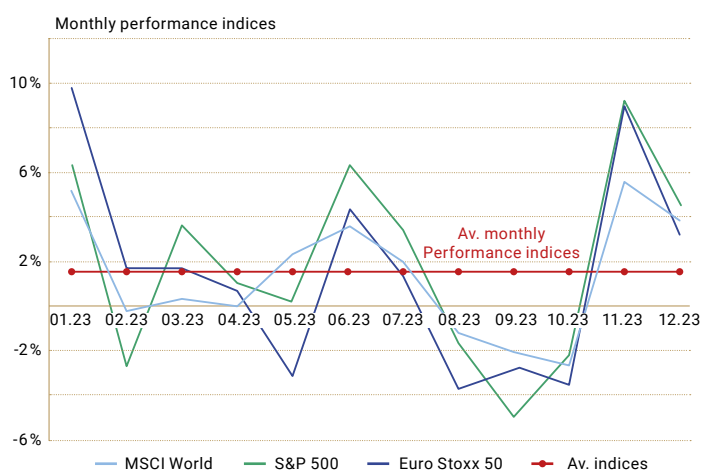
